To the Parent of:

Dear Parent,

Your child attends **Inwood Elementary**, which receives federal Title I funds to assist students in meeting state achievement standards. Your child's school has not met these standards in reading and/or mathematics for five years. This school has been identified as a School in Planning for Restructuring which means that the district must develop a plan to restructure the school.

As a parent, you are invited to participate in the planning process and submit comments on the proposed restructuring plan. Restructuring the school may include:

- Reopening as a charter school
- Replacing all or most school staff
- Allowing a private company to operate the school
- Other restructuring that changes the way the school operates

Compared to other schools in the district, your child's school is performing better in math and writing. The table below shows the percent of proficient students in our school compared to other schools in the district and state.

What are we doing about it?

- Developing a plan to monitor students' progress
- Providing an after school tutoring program in reading and math
- Extending the instructional day
- Providing training for teachers in effective teaching strategies

You are very important to your child's education. We invite you to become more involved in your child's school by:

- Attending educational workshops
- Reading to your child
- Assisting in the development of the plan for restructuring the school
- Communicating regularly with your child's teacher

Information regarding your child's teacher and paraprofessional qualifications will be provided to you in a timely manner upon request.

You have the right to request the following information:

- Whether the teacher has met the state licensing criteria for the grade levels and subject areas in which the teacher provides instruction.
- Whether the teacher is teaching under emergency or other provisional status through which state qualifications of licensing criteria have been waived.
- The baccalaureate degree major of the teacher and any other graduate certification or degree held by the teacher and the field of discipline of the certification or degree.
- Whether your child is provided services by paraprofessionals, and, if so, their qualifications.

You will be notified in writing if your child has been assigned or has been taught for more than four consecutive weeks by a teacher who has not met the *No Child Left Behind* "highly qualified" criteria. The information regarding the qualifications of your child's teacher and/or classroom paraprofessionals may be obtained from your child's principal.

Please be assured that the Polk County School District is dedicated to providing your child a quality education.
