### **State Board Plan For Repeat F Secondary Schools**

In 2006, the State Board of Education established 26 requirements for all repeated F schools. During the course of the 2006-2007 school year, four districts and seven schools implemented these requirements. Based upon their feedback, as well as on the experience of DOE staff members who have worked with these schools, this document suggests modifications to these 26 requirements.

Note: Changes from the original 26 requirements are noted in **red** on the following pages.

There must be a minimum of one coach per subject area.</b></p> <p><b>NOTE: All coaches must be approved by the Department.</b></p>

<b>Leadership</b>	<p><b><u>SBE Approved 4.18.06:</u></b>            Identification and hiring of proven educational leaders  <b>OR</b>            District provides justification for keeping existing principal and arranges for a mentor principal to guide existing principal.</p>
